I would like to add a point further to that response –

There seems to be a potential conflict between the terms of rule 5.7 and the associated form, Form 5B.

Rule 5.7 says that if the claimant has not [responded] to a Time to Pay Application [within two weeks of the Time to pay Notice] the sheriff must decide the case (if the case has not been decided) and grant or refuse [the application].

When a respondent seeks time to pay the form a Time to Pay notice form – form 5B - is sent to the claimant. The Form indicates that "[the claimant] must send [this notice] back to the court within two weeks after the Time to Pay Application is sent or else the court <u>will</u> dismiss your claim"(my emphasis).

Reading rule 5.7 together with the warning on form 5B (the form being part of the Act of Sederunt along with the rule) then the only decision available is to dismiss (if the claimant does not respond). That interpretation doesn't sit comfortably with the final words of rule 5.7 which require the sheriff to think about whether to grant or refuse time to pay.
