  that there will be an allocation for research purposes. Resources will, however,
  be limited. It is suggested that there would be merit in considering in further
  detail how research priorities should be decided and how these funds might
  best be allocated. Subject to agreement, this will be scheduled for discussion
  at the next SCJC meeting in March. In the meantime, members' general views
  would be welcome.
- 4) In addition, the Rules Rewrite Working Group visited England and Wales on 2-3 December and met academics and members and staff of the Civil Justice Council and Civil Procedure Rule Committee to discuss the experience there in respect of the Woolf and Jackson reforms.

- SLCC Report <u>Five years on facts and figures</u>: analyses five years of legal complaints data to see if there are any insights that can help legal practitioners and the public. The report includes information on: the areas of legal work that attract the most complaints; the most common types of complaints; and how complaint trends have changed over time.
- Scottish Government's Response to the consultation on Civil Law of Damages: Issues in Personal Injury. The SG has agreed to increase the limitation period for raising an action for damages for personal injury from three years to five years and clarity that it should not be possible for a bereaved relative to secure damages for psychiatric injury under the Damages (Scotland) Act 2011.
- Senatorial appointments <u>announced</u> on 18 December 2013: SCJC Member Sarah Wolffe QC, along with Sheriff Rita Rae QC.
- Housing Scotland Bill introduced 21 November 2013.
